In consideration of my dog(s) participating in any way in the daycare, boarding and grooming services with the Ponderosa Pet Ranch, I acknowledge and agree that-

- Owner agrees to pay the rate for boarding, daycare or grooming services upon pick up. Along with any veterinary care that may be needed during their time at PPR.
- Owner understands that there is a 15.00 charge for any boarding departures after 1pm.
- Owner agrees to pay a 10.00 late charge for any pick-ups after 5:30pm. Unless otherwise approved by management.
- It is mandatory that all pets must be vaccinated for animal diseases, (Rabies, Distemper and Bordetella) before entering the premises.
- All pets entering the facility must be treated for parasites, such as fleas, ticks, intestinal parasites etc. If seen by our staff- we may ask you to pick your pet up from our premises, or all treatment will be at the owner's expense.
- PPR is not responsible for your pet acquiring diseases while staying at PPR, or any costs associated with treatment of such illnesses (Canine Cough, intestinal parasites etc.)
- If the pet(s) becomes ill during their stay and needs veterinary attention, PPR has permission to provide necessary care at owners expense.
- Owner understands that there is a 7 day wait period after their pet has received their Bordetella vaccine.
- Owners may bring bedding, toys etc for their pet during their stay, PPR is not responsible for any lost or damaged belongings.
- The chance of scratches and punctures(not limited to) is higher for pets while in a group setting with other dogs. All of our play groups are supervised by trained staff and that will minimize the risk, the possibility of injury still is possible during play groups.
- Owner agrees to use their ONE month daycare package within 3 months of purchasing it.
- Owner agrees to use our 5 day-daycare package within 2 months of purchasing it.
- Our daycare packages are non-refundable and cannot be applied to other services at PPR.
- If you are scheduled for daycare and do not show without any notice, PPR will deduct a day from owners daycare package.
- If you no call/no show for boarding/daycare more than once, PPR reserves the right to require full payment when appointment is made.
- Owner agrees not to hold PPR responsible for any injuries, lost or damaged items associated with the dog park.
- Owner agrees to pick up after pet in dog park grounds.

- PPR shall exercise reasonable care for the pet. In the event PPR is liable for injury or death it is agreed upon by the owner and the facility that the pet owners compensation for said pet shall not exceed the sum of 300.00\$ per animal in our care.
- Owner agrees that in the event the boarding charges are not paid when due in accordance with the contract, PPR may exercise its legal right to hold pet(s) for 10 days while awaiting payment. After which pet(s) is placed for public sale for sufficient money to cover the charges incurred for said pets stay. If pet(s) is sold for insufficient amount to cover charges incurred, PPR will seek legal action against the pet owner.
- Owner agrees to be responsible for any and all acts of behavior of the pet while on the PPR property. Any damages by pet(s) must be paid by the owner. We reserve the right to ask you to remove your pet from the premises for any aggressive or undesirable behavior.
- PPR is not responsible for any injuries, and/or altercations in the dog park. It is to be used at the owner's own risk. We do require up-to-date vaccines for dog park guests but we do not police the dog park.
- Owner specifically represents that they are the sole owner of the pet.
- I knowingly and freely assume all such risks for my pet(s) in the care of PPR. By signing this contract and leaving pet(s) with PPR, the owner guarantees the accuracy of all information given.
- I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Ponderosa Pet Ranch, the owners, employees, volunteers and anyone else associated with PPR from any and all claims as a result of illness or injury to my pet(s) during participation in daycare, boarding and grooming.

I have read this authorization of veterinary care, release of liability and assumption of risk agreement, fully understand its terms and sign it freely and voluntarily. I authorize Ponderosa Pet Ranch to seek veterinarian care for my pet(s) and obtain any medical records for my pet(s) current or past.
